# Numerical approximation of a cash-constrained firm value with investment opportunities.

#### Abstract

We consider a singular control problem with regime switching that arises in problems of optimal investment decisions of cash-constrained firms. The value function is proved to be the unique viscosity solution of the associated Hamilton-Jacobi-Bellman equation. Moreover, we give regularity properties of the value function as well as a description of the shape of the control regions. Based on these theoretical results, a numerical deterministic approximation of the related HJB variational inequality is provided. We finally show that this numerical approximation converges to the value function. This allows us to describe the investment and dividend optimal policies.

## 1 Introduction

In a frictionless capital market, Modigliani and Miller theorem demonstrates that firms can fund all valuable investment opportunities. However, if we introduce capital market imperfections, it is now a standard result that cash-constrained firms have to rely more on internal financial resources: cash holdings and credit line to fund investment opportunities. In recent years, there has been an increasing attention in the use of singular control techniques to model investment problems of a cash-constrained firm. As references for the theory of singular stochastic control, we may mention the pioneering works of Haussman and Suo [9] and [10] and for application to investment/dividend problems Jeanblanc and Shiryaev [15], Højgaard and Taksar [11], Asmussen, Højgaard and Taksar [1], Choulli, Taksar and Zhou [4], Paulsen [19] while more recent studies in corporate finance include Bolton, Chen and Wang [3], Décamps, Mariotti, Rochet and Villeneuve [6] and Hugonnier, Malamud and Morellec [14].
Singular control is an important class of problems in stochastic control theory. The associated HJB equation, which takes the form of variational inequalities with gradient constraints turns out to be very difficult to solve. In particular, the regularity of the solution are still not

[^0]well understood. For concrete problems as those arising from dynamic corporate finance, it is thus important to propose a numerical approximation of the value function and to ensure that this numerical approximation converges to the targeted value function. It turns out from the paper by Barles and Souganidis [2] that when the value function of a singular control problem is the unique viscosity solution of the associated HJB variational inequality, a consistent, stable and monotone numerical scheme converges to the value function.
It is now well-established that there exist several approaches to approximate the value function of singular stochastic control problems. First, probabilistic methods based on Markov Chain approximations are essentially explicit finite difference schemes and thus suffer from the stability curse limiting the choice of time step (see [17]). On the other hand, analytical methods based on the tracking of control regions have been developed in [16]. They appear to be quite complex because they necessitate a good guess about the shape of control regions especially in the presence of multiple controls.
Our paper builds on the theoretical model of cash-constrained firms developed in [22] with the modification that the investment levels are here discrete. This assumption appears to be reasonable for big industries investing in capacity. The objective is to determine the firm value as well as the investment and dividend optimal policies leading to a singular control problem with regime switching where the regimes correspond to the different levels of production. Our main contributions are

- We prove that the value function is the unique viscosity solution of the HJB variational inequality. Moreover, we prove the regularity of the value function under a mild assumption about the existence of left and right derivative everywhere. Finally, we prove that it is optimal to pay dividends for high value of cash which allow us to set boundary conditions at right for our numerical scheme.
- We carry out a rigorous analysis of the direct control method proposed by [12], in the context of HJB variational inequality arising from cash management problem. Having proved a strong comparison theorem, we show that our direct control method is consistent, stable and monotone. In our context, the stability result appears to be a little bit tricky and its proof needs to prove a growth condition on the value function (see Lemma 2).
- Finally, the numerical approximation of the HJB variational inequality leads to the resolution of a linear system $A U=B$. We present a fixed-point iteration scheme similar to [12] for solving the linear system. To show the convergence of this iterative procedure, we need to prove that the tridiagonal block matrix A is a M-matrix (see Lemma 8) which necessitates an extension of the result proved in [12].

The paper is organized as follows: in section 2, we present the model and derive a standard analytical characterization of the value function in terms of viscosity solutions. Furthermore, we give regularity properties of the value function and a description of the shape of the control regions. Section 3 and 4 are devoted to the presentation of the numerical approximation and contains the convergence result which builds on an extension of the classical techniques developed in [12]. Section 5 concludes the paper with numerical illustrations.

## 2 The Model

We consider a firm characterized at each time $t$ by the following balance sheet :
$K_{t}+M_{t}=L_{t}+X_{t}$ where

- $K_{t}$ represents the firm's productive assets,
- $M_{t}$ represents the amount of cash reserves or liquid assets,
- $L_{t}$ represents the volume of outstanding debt,
- $X_{t}$ represents the book value of equity.

We suppose that the firm is able to choose the level of its productive assets, by investment or disinvestment, in a range of $N$ strictly positive levels : $K_{t} \in\left\{k_{i}\right\}_{i \in[1, N]}$. Without loss of generality, we suppose that $\left\{k_{i}\right\}_{i \in[1, N]}$ satisfy

The productive assets continuously generate cash-flows $\left(R_{t}\right)_{t \geq 0}$ over time. We assume

where $\mu$ and $\sigma$ are positive constants and $\left(B_{t}\right)_{t \geq 0}$ is a standard Brownian motion on a complete probability space $(\Sigma, \mathcal{F}, \mathbb{P})$ equipped with a filtration $\left(\mathcal{F}_{t}\right)_{t \geq 0}$. In this model, we assume a decreasing-return-to-scale technology by introducing the increasing bounded concave function $\beta$. We denote $\bar{\beta}$ the maximum taken by the gain function on $\left\{k_{i}\right\}_{i \in[1, N]}$ i.e.

In order to finance its working capital requirement, we consider that the firm has access to a secured credit line. The collateral of the credit line is given by the market value of the firm assets. If we introduce $\gamma>0$ the cost to disinvest the productive assets and $M$ the level of cash, the credit line's depth is assumed to be

When this credit line limit is reached, the company is no longer able to meet its financial commitments and is therefore forced to go bankrupt. At this point, the manager liquidates the firm assets in order to refund the creditors with priority for debt holders over shareholders. However, we assume that there is a probability $1-\zeta$ that the firm does not manage to sell its assets at their market value. Introducing $P$ the expected loss for the debt holders, we have

P=\zeta(1-\gamma) K
$$

This loss makes the credit line risky and thus it is subject to interest payments variable modeled by a function $\alpha$ depending only on the volume of debt the firm has issued. Finally, we suppose the access to equity market is excessively costly.

Assumption $1 \alpha$ is a strictly continuously differentiable convex function. Furthermore, it is assumed that the collateralized debt is risky, that is

This assumption is consistent with what we observe in practice. The convexity of $\alpha$ allows us to model the fact that the interest payments asked by the creditors increase with the level of debt. Note that the model doesn't exclude a linear cost of the debt since $\alpha$ is not supposed to be strictly convex. In [22], it has been proved in a similar framework that it is optimal to use the credit line if and only if the cash reserves are depleted meaning that

We therefore have the following dynamics for the book value of equity and the productive assets ([22]):

where $Z=\left(Z_{t}\right)_{t \geq 0}$ is an increasing right-continuous $\left(\mathcal{F}_{t}\right)_{t}$ adapted process representing the cumulative dividend payments up to time $t$ and $I^{+}=\left(I_{t}^{+}\right)_{t \geq 0}$ (respectively $I^{-}$) is the cumulative investment process (respectively disinvestment). Here we suppose that the cost to investment is the same as the cost of disinvestment $\gamma$.
The manager acts in the interest of the shareholders and maximizes the expected discounted value of all future dividend payout. Shareholders are assumed to be risk-neutral and future cash-flows are discounted at the risk-free rate $r$. Thus, the objective is to maximize over the admissible control $\pi=\left(I^{+}, I^{-}, Z\right)$ the functional

where $x$ and $k_{i}$ are the initial values of equity capital and productive capital. $\tau$ is the time of bankruptcy and according to (1) and (2), we have

We denote by $\Pi$ the set of admissible control variables and define the shareholders value functions by

### 2.1 Viscosity solutions

The aim of this section is to determine the HJB variational inequality (HJB-VI) satisfied by the shareholders value functions $\left(v_{i}\right)_{i \in[1, N]}$. This analytical characterization will allow us to solve numerically the problem of optimal investment for a cash-constrained firm.

Proposition 1 The shareholders value functions $v_{i}$ are jointly continuous for every $i \in$ $[1, N]$.

Proof: Take $i \in[1, N], x>\gamma k_{i}$ and $\left(x_{n}\right)_{n \in \mathbb{N}}$ a sequence of $\Omega_{i}$ that converges to $x$. We consider two admissible strategies :

- Strategy $\pi_{n}^{1}$ : from $\left(x, k_{i}\right)$ wait until liquidation or the point $\left(x_{n}, k_{i}\right)$. We denote $\left(X_{t}^{\pi_{n}^{1}}, K_{t}^{\pi_{n}^{1}}\right)_{t \geq 0}$ the process controlled by $\pi_{n}^{1}$.
- Strategy $\pi_{n}^{2}$ : from $\left(x_{n}, k_{i}\right)$ wait until liquidation or the point $\left(x, k_{i}\right)$. We denote $\left(X_{t}^{\pi_{n}^{2}}, K_{t}^{\pi_{n}^{2}}\right)_{t \geq 0}$ the process controlled by $\pi_{n}^{2}$.

We define

The next lemma establishes a comparison principle which we shall use to prove a linear growth condition for the shareholders value function.

Lemma 1 Suppose $\left(\varphi_{i}\right)_{i \in[1, N]}$ are $N$ smooth functions on $\left(\gamma k_{i},+\infty\right)$ such that $\varphi_{i}\left(\gamma k_{i}\right) \geq 0$ and

Proof: Take $i \in[1, N], X(0)=x \in \Omega_{i}$ and $\pi=\left(Z, I^{+}, I^{-}\right)$an admissible control. We note $\left(I_{n}\right)_{n \geq 1}$ the moments of regime switching. Apply then Itô's formula to $e^{-r t} \varphi_{i}\left(X_{t}^{\pi}\right)$ between 0 and the stopping time $\left(I_{1} \wedge \tau\right)$ noticing that for $0 \leq t<I_{1} \wedge \tau$, the firm stays in the regime $k_{i}$.

Noting that the integrand in the stochastic integral term is bounded we have

As a corollary, we prove a linear growth condition for the shareholders value functions $v_{i}$.

and we have $\varphi_{i}\left(\gamma k_{i}\right)=\frac{\mu \bar{\beta}}{r}>v_{i}\left(\gamma k_{i}\right)$ using that $v_{i}\left(\gamma k_{i}\right)=0$. Lemma 1 proves the result. $\diamond$

Proposition 2 The shareholders value functions $\left(v_{i}\right)_{i \in[1, N]}$ are the unique continuous viscosity solutions to the $H J B$ variational inequality :

Proof: The proof is postponed to the Appendix and is somehow similar to the one in [22]. $\diamond$

Remark 1 It is sufficient to impose the boundary condition (8) to have the uniqueness of the viscosity solution.

Remark 2 Given the property $v_{i}(x) \geq v_{j}\left(x-\gamma\left|k_{i}-k_{j}\right|\right)$, the HJB-VI is equivalent to

### 2.2 Regularity

We set for all $i \in[1, N]$,

which define the investment region $\left(\mathcal{S}_{i}^{+}\right)$and the disinvestment one $\left(\mathcal{S}_{i}^{-}\right)$.
Before proving the main result of this section, we need to establish some preliminary results on the value function.

Lemma $3 \forall i \in[1, N], v_{i}(x+h) \geq v_{i}(x)+h$

Proof: It is obvious if we consider the sub-optimal strategy from initial state $\left(k_{i}, x+h\right)$ which consists on distributing $h$ dollars as dividends at time $t=0$ and following the optimal strategy hereafter. By the dynamic programming principle we have :

Proof: We prove only the first assertion since the demonstration of the second assertion is similar. Suppose on the contrary that there exists $i \in[1, N]$ and $x \in S_{i}^{+}$such that $x-\gamma h \in S_{i+1}^{-}$. Therefore,

We proved in the previous section that the value function is continuous. It has been proved in [20] that the convexity of the value function is a sufficient condition for the regularity of its derivative. But, as proved in [22], the value function might be convex-concave when the credit line interest rate is high. Nonetheless, we will give below a regularity result under the following assumption about the existence of left and right derivatives.

Assumption 2 The value function admits left ( $D^{-}$) and right ( $D^{+}$) derivatives on its definition domain.

Proposition 3 Under the assumption (2), the value functions $v_{i}$ are $C^{1}$ for all $i \in[1, N]$,

Proof: Let be $i \in[1, N], x_{0} \in \Omega_{i}$ and suppose $D^{+} v_{i}\left(x_{0}\right)>D^{-} v_{i}\left(x_{0}\right)$. Then take some $q \in\left(D^{-} v_{i}\left(x_{0}\right), D^{+} v_{i}\left(x_{0}\right)\right)$ and consider the function

Let's prove now that $v_{i}$ is still $C^{1}$ on $\mathcal{S}_{i}$. Fix $x_{0} \in \mathcal{S}_{i}^{+}$(the proof for $x_{0} \in \mathcal{S}_{i}^{-}$is similar) and take $j=\min \left\{l>i, x_{0}-\gamma\left|k_{i}-k_{l}\right| \notin \mathcal{S}_{l}^{+}\right\}$. Then $x_{0}$ is a minimum of $v_{i}-v_{j}\left(.-\gamma\left(k_{j}-k_{i}\right)\right)$, and so

But, from the definition of $j, x_{0}-\gamma\left(k_{j}-k_{i}\right) \notin S_{j}^{+}$and from Lemma 4, $x_{0}-\gamma\left(k_{j}-k_{i}\right) \notin S_{j}^{-}$ so $x_{0}-\gamma\left(k_{j}-k_{i}\right)$ belongs to the open set $\Omega_{j} \backslash S_{j}$ and so $D^{+} v_{j}\left(x_{0}-\gamma\left(k_{j}-k_{i}\right)\right)=D^{-} v_{j}\left(x_{0}-\right.$ $\left.\gamma\left(k_{j}-k_{i}\right)\right)$ and thus

Classical results (see for instance [8]) provide the existence and uniqueness of a smooth $C^{2}$ function $w$ solution on $\left(x_{1}, x_{2}\right)$ to (10). In particular, this smooth function $w$ is a viscosity solution to (9). From standard uniqueness results, we get $v_{i}=w$ on $\left(x_{1}, x_{2}\right) \in \mathcal{C}_{i}$ which proves that $v_{i}$ is $C^{2}$ on $\mathcal{C}_{i}$ from the arbitrariness of $\left(x_{1}, x_{2}\right)$.

### 2.3 Properties of the dividend region

At this point, we only have the boundary condition :

For all $i \in[1, N]$, the function $x \rightarrow v_{i}(x)-x$ is an increasing bounded continuous function (see lemma 2) and therefore admits a limit $a_{i}=\lim _{x \rightarrow+\infty}\left(v_{i}(x)-x\right)$. We have for all $(i, j) \in[1, N] \times[1, N]:$

\forall x>\bar{x}, v_{i}\left(x-\gamma\left|k_{i}-k_{j_{0}}\right|\right)-w(x) & =v_{i}\left(\bar{x}-\gamma \mid k_{i}-k_{j_{0}}\right)+x-\bar{x}-\left(v_{j_{0}}(\bar{x})+x-\bar{x}\right) \\
& =v_{i}\left(\bar{x}-\gamma\left|k_{i}-k_{j_{0}}\right|\right)-v_{j_{0}}(\bar{x}) \\
& \leq 0
\end{aligned}
$$

We proved that $w$ is a viscosity solution to the variational inequality so by uniqueness, $w=v_{j_{0}}$, which is in contradiction with $j_{0} \in \mathbb{I}^{c}$ and the result is proved.

Lemma 5 ensures that if $x$ is large enough, we have $v_{i}(x+h)=v_{i}(x)+h$. This property, with the left boundary condition at $\gamma k_{i}$ is enough to build a numerical scheme. However, we can prove more about the dividend region. Proposition 5 below specifies the form of the dividend region under certain assumption and builds on the two next lemmas.

Definition 1 We say that $x \in \Omega_{i}$ is a left border (resp. right border) of a subset $\mathcal{E}$ if there exists $\epsilon>0$ and $\left(x_{n}\right)_{n \in \mathbb{N}} \notin \mathcal{E}$ such that

Moreover, as $a_{i} \in \overline{\mathcal{C}}_{i}$, it exists $\delta$ such that $] a_{i}-\delta, a_{i}\left[\subset \mathcal{C}_{i}\right.$ and $v_{i}$ is $C^{2}$ over this interval (see Proposition 4). Using Lemma 3, we have $v_{i}^{\prime \prime}\left(a_{i}^{-}\right) \leq 0$. So using the differential equation satisfied by $v_{i}$ over $] a_{i}-\delta, a_{i}[$, we have

Proof: Suppose there is another non-empty interior subset in $\mathcal{D}_{i}$, then it exists a right and a left border that we note $d_{i}$ and $g_{i}$. We prove the result in two steps.

First step: Suppose $g_{i}=\gamma k_{i}$.
There exists $\epsilon>0$ such that $\left[\gamma k_{i}, \gamma k_{i}+\epsilon\right] \subset \mathcal{D}_{i}$. So for all $x \in\left[\gamma k_{i}, \gamma k_{i}+\epsilon\right], v(x)=x-\gamma k_{i}$ and

Using Lemma 7 we know that $g_{i} \geq k_{i}$, so $d_{i}>k_{i}$. This means that there exists $\epsilon>0$ such that $d_{i}-\epsilon \geq k_{i}$ and

\left.\forall x \in] d_{i}-\epsilon, d_{i}\right], v_{i}(x)=v_{i}\left(d_{i}\right)+x-d_{i}
$$

Using then that $-\mathcal{L}_{i} v_{i}(x) \geq 0$ over $\left.] d_{i}-\epsilon, d_{i}\right]$, we have that

v_{i}\left(d_{i}\right) \geq \frac{\mu \beta\left(k_{i}\right)}{r}
$$

Using again Lemma 7 , as $b_{i} \notin \mathcal{S}_{i}$, then

v_{i}\left(b_{i}\right)=\frac{\mu \beta\left(k_{i}\right)}{r}
$$

which is a contradiction since $b_{i}>d_{i}$ and $v_{i}$ is a strictly increasing function.

## 3 Numerical Approximation

The aim of this section is to produce a grid and a discretization by means of central, forward and backward differencing of the free boundary problem (7). We prove that the scheme is monotone and therefore converges to the solution (see [7]).

### 3.1 Finite difference method

First we make the following change of variable :

Clearly, $w_{i}$ is the unique viscosity solution of the free boundary problem

\min \left(-\mathcal{L}_{i}^{\prime} w_{i}(x), w_{i}(x)-1, w_{i}(x)-\max \left(w_{i-1}(x-2 \gamma h), w_{i+1}(x-2 \gamma h)\right)\right)=0 \tag{11}
\end{equation*}
$$

with,

$$
\mathcal{L}_{i}^{\prime} \phi(x)=\left(\mu \beta\left(k_{i}\right)-\alpha\left(\left((1-\gamma) k_{i}-x\right)^{+}\right)\right) \phi^{\prime}(x)+\frac{\beta\left(k_{i}\right)^{2} \sigma^{2}}{2} \phi^{\prime \prime}(x)-r \phi
$$

which we will continue thereafter to note $\mathcal{L}_{i}$. We also define the operator $\tilde{\mathcal{I}}$ for a function $\phi$ and a point $x$ that gives the linear interpolation of $\phi$ at the point $x-2 \gamma h$.

Remark 3 Remind that there isn't investment for $i=N$ neither disinvestent for $i=1$. So in the precedent definition, we suppose that the condition $v_{i}(x)-v_{i-1}(x-\gamma h)$ (resp. $v_{i}(x)-v_{i+1}(x-\gamma h)$ ) fades away when $i=1$ (resp. $\left.i=N\right)$.

From the previous section, we know that for all $i \in[1, N]$, there exists $b_{i}$ such that $w_{i}^{\prime}(x)=1$ over $\left[b_{i},+\infty\left[\right.\right.$. So taking $x_{\max }>\max _{i}\left\{b_{i}\right\}$ we have the boundaries conditions :

Problem (11) is therefore solved on the computational domain

with the regular grid $\left(x_{l}\right)_{l \in[1, M]}=\{(l-1) \Delta x\}_{l \in[1, M]}$ with

\Delta x=\frac{x_{\max }}{M-1}
$$

in order to have $x_{M}=x_{\max }$. Let $W_{l, i}$ be the approximate solution of equation (11) at ( $x_{l}, k_{i}$ ) for every $i \in[1, N]$ and $l \in[1, M]$. We use a direct method similar to [12] to discretize equation (11) as well as central differencing as much as possible in order to improve the efficiency. Setting $\tilde{\mathcal{L}}_{i}$ the discretization of $\mathcal{L}_{i}$, we have:

= & -\rho_{l, i}\left(1-\theta_{l, i}\right)\left(W_{l, i}-W_{l, i-1}\right)-\left(1-\rho_{l, i}\right)\left(W_{l, i}-\tilde{\mathcal{I}} W_{l, i+1}\right)
\end{align*}
$$

with,

$$
\begin{aligned}
\left\{\rho_{l, i}, \theta_{l, i}, \psi_{l, i}\right\}=\operatorname{argmin}_{\substack{\rho \in\{0,1\} \\
\theta \in\{0,1\} \\
\psi \in\{0,1\}}}\{ & \rho_{l, i}\left[\theta_{l, i}\left(-\psi_{l, i}(\tilde{\mathcal{L}} W)_{l, i}+\left(1-\psi_{l, i}\right)\left(\frac{W_{l, i}-W_{l-1, i}}{\Delta x}-1\right)\right)\right] \\
& \left.+\rho_{l, i}\left(1-\theta_{l, i}\right)\left(W_{l, i}-W_{l, i-1}\right)+\left(1-\rho_{l, i}\right)\left(W_{l, i}-\tilde{\mathcal{I}} W_{l, i+1}\right)\right\}
\end{aligned}
$$

The terminal boundary condition $w_{i}^{\prime}\left(x_{M}\right)=1$ is classically discretized :

W_{M, i}=W_{M-1, i}+\Delta x, i \in[1, N]
$$

and we also have

W_{0, i}=0, i \in[1, N]
$$

If we denote

C_{2}\left(x_{l}, k_{i}\right)=\frac{\sigma^{2} \beta\left(k_{i}\right)^{2}}{2}>0
\end{array}\right.
$$

then to satisfy the positive coefficient condition and to maximize the efficiency, the discretized operator $\tilde{\mathcal{L}}_{i}$ is given by :

(\tilde{\mathcal{L}} W)_{l, i}=\left\{\begin{array}{l}
C_{2}\left(x_{l}, k_{i}\right) \frac{W_{l+1, i}+W_{l-1, i}-2 W_{l, i}}{\Delta x^{2}}+C_{1}\left(x_{l}, k_{i}\right) \frac{W_{l+1, i}-W_{l-1, i}}{2 \Delta x}-r W_{l, i} \\
\text { if } 2 C_{2}\left(x_{l}, k_{i}\right) \geq\left|C_{1}\left(x_{l}, k_{i}\right)\right| \Delta x \text { (central differencing) } \\
C_{2}\left(x_{l}, k_{i}\right) \frac{W_{l+1, i}+W_{l-1, i}-2 W_{l, i}}{\Delta x^{2}}+C_{1}\left(x_{l}, k_{i}\right) \frac{W_{l+1, i}-W_{l, i}}{\Delta x}-r W_{l, i} \\
\text { if } 2 C_{2}\left(x_{l}, k_{i}\right)<\left|C_{1}\left(x_{l}, k_{i}\right)\right| \Delta x \text { and } C_{1}\left(x_{l}, k_{i}\right) \geq 0 \text { (forward differencing) } \\
C_{2}\left(x_{l}, k_{i}\right) \frac{W_{l+1, i}+W_{l-1, i}-2 W_{l, i}}{\Delta x^{2}}+C_{1}\left(x_{l}, k_{i}\right) \frac{W_{l, i}-W_{l-1, i}}{\Delta x}-r W_{l, i} \\
\text { if } 2 C_{2}\left(x_{l}, k_{i}\right)<\left|C_{1}\left(x_{l}, k_{i}\right)\right| \Delta x \text { and } C_{1}\left(x_{l}, k_{i}\right)<0 \text { (backward differencing) }
\end{array}\right.
$$

Proposition 6 The scheme is monotone, consistent and stable.

Proof: The scheme is, as a finite difference scheme, consistent. Moreover, we check easily that in $-(\mathcal{L} W)_{i, l}$, the coefficients in front of $W_{l-1, i}, W_{l+1, i}, W_{l, i-1}$ are negatives. So are the coefficients in front of $W_{k, i+1}$ for $k$ acting in the interpolation $\mathcal{I} W_{l, i+1}$. On the contrary, the coefficient in front of $W_{l, i}$ is positive which proves the monotony. We still have to prove the stability i.e. to prove that for all $\Delta x$, the schema has a solution $\left(W_{l, i}\right)_{i, l}$ which is uniformly bounded independently of $\Delta x$. First, equation (13) implies that

$$
\begin{equation*}
\forall i \in[1, N], \forall l \in[2, M], W_{l, i} \geq W_{l-1, i}+\Delta x \geq W_{l-1, i} \tag{14}
\end{equation*}
$$

so the sequence $l \rightarrow W_{l, i}$ is increasing. Let's prove that $W_{M, i}$ is bounded independently of $\Delta x$. We know by the terminal boundary condition that

1. $-(\tilde{\mathcal{L}} W)_{d, i}=0$.
2. $W_{d, i}-W_{d, i-1}=0$.
3. $W_{d, i}-\tilde{\mathcal{I}} W_{d, i+1}=0$.
and by definition of $d$ :

Case 1: Using the discretized operator, we have in the central differencing case :

$$

Factoring,

r W_{d, i}=C_{1}\left(x_{d}, k_{i}\right)+\left(-\frac{C_{2}\left(x_{d}, k_{i}\right)}{\Delta x^{2}}+\frac{C_{1}\left(x_{d}, k_{i}\right)}{2 \Delta x}\right)\left(W_{d, i}-W_{d-1, i}-\Delta x\right)
$$

so, using that $W_{d, i} \geq W_{d-1, i}+\Delta x$ and the central differencing inequation, we have

W_{d, i} \leq \frac{C_{1}\left(x_{d}, k_{i}\right)}{r}
$$

Moreover, $C_{1}\left(x_{d}, k_{i}\right)$ is bounded independently of $\left(x_{d}, k_{i}\right)$ by $\mu \bar{\beta}$. Then,

W_{d, i} \leq \frac{\mu \bar{\beta}}{r}
$$

But, by definition of $d$,

W_{M, i}=W_{d, i}+(M-d) \Delta x
$$

so

W_{M, i} \leq \frac{\mu \bar{\beta}}{r}+(M-d) \Delta x \leq \frac{\mu \bar{\beta}}{r}+x_{M}
$$

The proof for the forward and backward differencing is similar and therefore omitted.
Case 2: In this case, let's define $p=\max \left\{j \in[1, i-1], W_{d, j}-W_{d, j-1}>0\right\}$. At this point, we necessarily have $-\tilde{\mathcal{L}} W_{d, p}=0$. Let's prove that we also have

Suppose that $W_{d+1, p}>W_{d, p}+\Delta x$. Then, using that $W_{d, p}=W_{d, i}$

But by definition of $d, W_{d, i}+\Delta x=W_{d+1, i}$, so

which is a contradiction since $p<i$. So we have

-\tilde{\mathcal{L}} W_{d, p}=0

and we can use the first case to prove that

W_{d, i} \leq \frac{\mu \bar{\beta}}{r}+x_{M}

The proof in the third case is similar and is therefore omitted.
Finally, we have proved in all cases that

\forall i \in[1, N], \forall l \in[1, M], W_{l, i} \leq \frac{\mu \bar{\beta}}{r}+x_{M}
$$

which is a bound independent of $\Delta x$ and the result is proved.

### 3.2 Matrix Form of the Discretized Equations

We denote $U$ the vector of size $N \times M$ and $\hat{U}_{i}$ for $i \in[1, N]$ the vectors of size $M$ such that

where $A(\rho, \psi, \theta)$ is a square tridiagonal block matrix of size $N \times M$ :

with $Z^{i}$ the tridiagonal matrix of size $M$ given by,

t_{l, l}^{i}=\rho_{l, i} \theta_{l, i}\left(\psi_{l, i}\left(r+\frac{2 C_{2}\left(x_{l}, k_{i}\right)}{\Delta x^{2}}+\frac{\left|C_{1}\left(x_{l}, k_{i}\right)\right|}{\Delta x} 1_{\left\{2 C_{2}\left(x_{l}, k_{i}\right)<\Delta x\left|C_{1}\left(x_{l}, k_{i}\right)\right|\right\}}\right)+\frac{\left(1-\psi_{l, i}\right)}{\Delta x}\right) \\
t_{l, l+1}^{i}=\rho_{l, i} \theta_{l, i}\left(-\psi_{l, i}\left(\frac{C_{2}\left(x_{l}, k_{i}\right)}{\Delta x^{2}}+\frac{C_{1}\left(x_{l}, k_{i}\right)}{2 \Delta x}+\frac{\left|C_{1}\left(x_{l}, k_{i}\right)\right|}{2 \Delta x} 1_{\left\{2 C_{2}\left(x_{l}, k_{i}\right)<\Delta x\left|C_{1}\left(x_{l}, k_{i}\right)\right|\right\}}\right)\right) \\
t_{l, l-1}^{i}=\rho_{l, i} \theta_{l, i}\left(-\psi_{l, i}\left(\frac{C_{2}\left(x_{l}, k_{i}\right)}{\Delta x^{2}}-\frac{C_{1}\left(x_{l}, k_{i}\right)}{2 \Delta x}+\frac{\left|C_{1}\left(x_{l}, k_{i}\right)\right|}{2 \Delta x} 1_{\left\{2 C_{2}\left(x_{l}, k_{i}\right)<\Delta x\left|C_{1}\left(x_{l}, k_{i}\right)\right|\right\}}\right)-\frac{\left(1-\psi_{l, i}\right)}{\Delta x}\right)
\end{array}\right.
$$

To fulfill the Dirichlet conditions, we force :

The form of the matrix $D^{i}$ is given by the operator $\tilde{\mathcal{I}}$. To have a monotone scheme, we need to use a linear operator. With a constant step, the form of the matrix is as follows :


The offset $d$ with respect to the diagonal in the matrix $D^{i}$, i.e the number of zero lines at the beginning of $D^{i}$, is equal to

where $E$ is the floor function. We also define the fractional part :

Last, the vector $B$, is of size $N \times M$ and satisfies

Definition $2 A$ matrix $A$ is a $M$-matrix if $A$ is non singular, the off-diagonal coefficients of $A$ are negatives and $A^{-1} \geq 0$.

Remark $4 A$ matrix such that $A^{-1} \geq 0$ satisfies

X \geq 0 \Leftrightarrow A^{-1} X \geq 0
$$

Lemma 8 The matrices $Z^{i}(\rho, \psi, \theta)=\left(z_{l, j}^{i}\right)_{l, j}$ are $M$-matrices.

Proof: Take $i \in[1, N]$. We observe that the matrix $Z^{i}$ satisfies for all $l, z_{l l}^{i}>0$ and for all $l \neq j, z_{l j}^{i} \leq 0$. Moreover $Z^{i}$ is a diagonally dominant matrix. Indeed,

\forall l \in[2, M], z_{l l}^{i}-\sum_{j \neq l}\left|z_{l, j}^{i}\right|= \begin{cases}r, & \psi_{l i} \rho_{l, i} \theta_{l, i}=1 \\ 0, & \psi_{l i}=0 \text { et } \rho_{l, i} \theta_{l, i}=1 \\ 1, & \rho_{l i} \theta_{l i}=0\end{cases}
$$

For $l=1$, Dirichlet condition dictates that

However the matrix is not a strict diagonally dominant matrix since when there is distribution of dividends (i.e. $\psi_{l i}=0$ and $\rho_{l, i} \theta_{l, i}=1$ ), the sum of the line coefficients is equal to zero and thus the classical technique used in [12] does not apply. Another way to prove that $Z^{i}(\rho, \psi, \theta)$ is a M-matrix is to find a M-size vector $W$ such that $W>0$ and $Z^{i} W>0$ (see [21]). Let's prove that $W$ the M-size vector given by

\epsilon=\frac{r \Delta x}{\mu \bar{\beta}}>0

satisfies this condition for all $i \in[1, N]$. First, as $Z^{i}$ is a tridiagonal matrix, we have

\left(Z^{i} W\right)_{1}=(1+\epsilon)
$$

and for $l=M$

\left(Z^{i} W\right)_{M}=\frac{1+M \epsilon}{\Delta x}-\frac{1+(M-1) \epsilon}{\Delta x}
$$

Then, for all $l \in[2, M]$, we have :

\left(Z^{i} W\right)_{l}=\left\{\begin{array}{lr}
(1+(l-1) \epsilon) r+\epsilon\left(z_{l l}^{i}+2 z_{l, l+1}^{i}\right), & \rho_{l i} \theta_{l i} \psi_{l i}=1 \\
\frac{\epsilon}{\Delta x}, & \rho_{l i} \theta_{l i}=1 \text { et } \psi_{l i}=0 \\
1+l \epsilon, & \rho_{l i} \theta_{l i}=0
\end{array}\right.
$$

Moreover, when $\rho_{l i} \theta_{l i} \psi_{l i}=1$, we have

$$
z_{l l}^{i}+2 z_{l, l+1}^{i}=r-\frac{C_{1}\left(x_{l}, k_{i}\right)}{\Delta x}
$$

So,

$$
\begin{aligned}
(1+(l-1) \epsilon) r+\epsilon\left(z_{l l}^{i}+2 z_{l+1, l}^{i}\right) & =(l-1) r \epsilon+r+\epsilon\left(r-\frac{C_{1}\left(x_{l}, k_{i}\right)}{\Delta x}\right) \\
& \geq l r \epsilon+r-\epsilon \frac{C_{1}\left(x_{l}, k_{i}\right)}{\Delta x}
\end{aligned}
$$

Using the definition of $\epsilon$ and the fact that

$$
\forall i \in[1, N], \forall l \in[1, M], C_{1}\left(x_{l}, k_{i}\right) \leq \mu \bar{\beta}
$$

we have that

$$
(1+(l-1) \epsilon) r+\epsilon\left(z_{l l}^{i}+2 z_{l+1, l}^{i}\right) \geq \operatorname{lr} \epsilon
$$

So

$$
\forall l \in[1, M],\left(Z^{i} W\right)_{l}>0
$$

And we conclude that $Z^{i}$ is a M-matrix.
Corollary 1 The matrix $A(\rho, \theta, \psi)$ is a M-matrix.

Proof: To prove the result we use the same technique as in Lemma 8. Choose

Using that the matrices $Z^{i}$ are diagonally dominant, we have that

In the case $\left(\theta_{l i}, \rho_{l, i}\right)=(0,1)$, we have

(A W)_{l+(i-1) M}=1+l \epsilon+i \eta-(1+l \epsilon+(i-1) \eta)=\eta>0
$$

and in the case $\rho_{l, i}=0$, we have

(A W)_{l+(i-1) M}= & 1+l \epsilon+i \eta-(1-\lambda)[1+(l-d) \epsilon+(i+1) \eta] \\
& -\lambda[1+(l-1-d) \epsilon+(i+1) \eta] \\
= & (d+\lambda) \epsilon-\eta \\
& >0
\end{aligned}
$$

Thus, we display a vector $W>0$ such that, for all $i \in[1, N]$, for all $l \in[1, M],(A W)_{l+(i-1) M}>$ 0 which proves he result.

## 4 Convergence of the scheme

The main result of this section is that $U$ is the solution of the following Newton algorithm :

$$
\begin{equation*}
A^{q} U^{q+1}+B^{q}=0 \tag{17}
\end{equation*}
$$

with

$$

the scheme in Algorithm 1 converges to the unique solution of equation (16).

Proof: The proof is classic and is posponed in appendix.

Lemma 9 The sequence $\left(U^{q}\right)_{q \geq 0}$ is bounded.

Proof: To prove the result, we have to prove that the matrices $\left(A^{q}\right)^{-1}$ and $B^{q}$ are bounded, regardless of $q$. First, by definition, we have that for all $q \geq 0$ and for all $j \in[1, N \times M]$, $b_{j}^{q} \leq 1$, so the matrix $B^{q}$ is bounded. Moreover, since $\rho^{q}, \theta^{q}$ and $\psi^{q}$ take discrete values :

## 5 Numerical results

### 5.1 Description of the optimal regions

In chapter 2.3, we proved that for all $i \in[1, N]$ there exists $b_{i}>k_{i}$ such that the dividend region contains at least $\left[b_{i},+\infty[\right.$, which allows us to define in the numerical scheme a border condition. The numerical results give us much more information about the optimal control regions. Next Proposition resumes those results :

Proposition 7 The optimal control regions satisfy

1. $\forall i \in[1, N], \mathcal{D}_{i}=\left[b_{i},+\infty[\right.$.
2. $\forall i \in[2, N], \exists d_{i} \in \Omega_{i}, \mathcal{S}_{i}^{-}=\left[\gamma k_{i}, d_{i}\right]$

Figure 1 illustrates Proposition 7. The results are obtained using a linear debt and an exponential gain function :

- Linear debt : $\alpha(x)=\lambda x$
- Exponential gain function : $\beta(x)=\bar{\beta}\left(1-\exp \left(-\frac{\eta}{\beta} x\right)\right)$
and the next values for the different parameters :

Figure 1: Optimal control regions.

In figure 1, we differentiate six areas:

1. $\mathcal{S}_{i}^{-}$(Orange zone) : Disinvestment area where the book value of equity is low in comparison to the level of the firm's productive assets. In this zone, it is optimal to disinvest to lower the risk of bankruptcy.
2. $\mathcal{S}_{i}^{+}$(Blue area) : Investment area where the ratio book value of equity over firm's productive assets is high. It is optimal to invest to increase the rentability via the gain function. The risk increases proportionnaly but the cash reserves protect the company against bankrupcy.
3. $\mathcal{C}_{i}$ (Black area) : In between, there is the continuation area where it is optimal to not activate the controls.

As proved in chapter 2.3, we observe that on the right side of figure 1, corresponding to a high level of equity, it is always optimal to pay dividends leading to three different areas :
4. $\mathcal{S}_{i}^{+} \cap \mathcal{D}_{i}$ (Green and blue area) : for a low level of productive assets. In this zone, it is optimal to pay dividends and invest until reach the optimal level $k^{*}$.
5. $\mathcal{S}_{i}^{-} \cap \mathcal{D}_{i}$ (Green and orange area) : for a high level of productive assets. In this zone, it is optimal to disinvest until a maximum level of productive assets $k_{\max }$ in order to distribute dividends.
6. $\mathcal{D}_{i}$ (Green area) : in between, it isn't optimal to invest neither to disinvest but just to pay dividends.

Those results are consistent with the economic theory. Furthermore, they bring to light two meaningful conclusions :

- It is optimal to pay dividends only once the company has reached a optimal size depending of its sector.
- There exists a maximum size that the company shouldn't exceed.

Those conclusions are directly attributable to the characteristics of the gain function chosen. Indeed, the rentability increases with the gain function which is concave with a finite limit at the infinity. So at some point, the marginal gain is small compared to the value for the shareholders to receive dividends.

### 5.2 Impact of the cost of investment

The cost of investment $\gamma$ (and of disinvestment) plays an important role in the form of the switching regions. Figure 2 to 4 , present the optimal control regions for different values of $\gamma$ and the same parameters than figure 1.


Figure 2: Optimal control regions for $\gamma=0.05$.


Figure 3: Optimal control regions for $\gamma=0.1$.


Figure 4: Optimal control regions for $\gamma=0.5$.

We observe that the higher $\gamma$ is, the wider the continuation region is. Which is consistent since if the cost is low the manager is prone to invest since he knows that he could desinvest at lower prices.

## 6 Appendix

### 6.1 Proof of Proposition 2

## Supersolution

0<c_{0} & \leq \mathbb{E}\left[e^{-r \tau_{1}} \psi\left(X_{\tau_{1}^{-}}^{\pi}\right) 1_{\tau_{1} \leq \tau_{\epsilon}}\right] \\
& +\mathbb{E}\left[\int_{0}^{\tau^{-}} e^{-r t} d t+\int_{0}^{\tau^{-}} e^{-r t} d Z_{t}^{\pi}\right] \\
& +\mathbb{E}\left[\theta e^{-r \tau_{\epsilon}} \Delta Z_{\tau_{\epsilon}} 1_{\tau_{\epsilon}<\tau_{1}}\right] .
\end{aligned}
$$

Using that $\psi(x) \leq 1$ for all $x \in] \bar{x}-\epsilon, \bar{x}+\epsilon[$, we have the result (23). Finally, by taking the supremum over all the admissible strategies and using the dynamic programming principle, (22) implies that $v_{i}(\bar{x}) \geq v_{i}(\bar{x})+\eta c_{0}$ which is a contradiction. So the subsolution property of $v_{i}$ is proved.

## Uniqueness property

Suppose that $\left(v_{i}\right)_{i \in[1, N]}$ are continuous viscosity subsolutions of $(7)$ and $\left(w_{i}\right)_{i \in[1, N]}$ continuous viscosity supersolutions, satisfying the boundary conditions

$$
u_{i}\left(\gamma k_{i}\right) \leq w_{i}\left(\gamma k_{i}\right)
$$

and the linear growth

$$
\forall x \in\left[\gamma k_{i},+\infty\left[,\left|u_{i}(x)\right|+\left|w_{i}(x)\right|<C_{1}+C_{2} x\right.\right.
$$

We will show that $u_{i}(x) \leq w_{i}(x)$ for $x \in\left[\gamma k_{i},+\infty[\right.$.
Step 1
We first construct strict supersolutions to (7) with pertubations of $w_{i}$. Set :

$$
\forall x \geq \gamma k_{i}, p(x)=A+B x+x^{2}
$$

with

$$
\begin{aligned}
& A=\frac{1+\mu \bar{\beta} B+\sigma^{2} \bar{\beta}^{2}}{r}+\sum_{i \in[1, N]} w_{i}\left(\gamma k_{i}\right) \\
& B=2+2 \gamma h+\frac{2 \mu \bar{\beta}}{r}
\end{aligned}
$$

Remark 5 The constant $A$ is expressed as the sum of two terms. The first one assures the strict supersolution property while the second one, the sum of $w_{i}\left(\gamma k_{i}\right)$, assures in the second step of the demonstration that for all $i \in[1, N], \lim _{x \rightarrow \gamma k_{i}}\left(u_{i}(x)-w_{i}^{\theta}(x)\right)<0$.

We then define for all $\theta \in] 0,1\left[\right.$, the next continuous functions on $\left[\gamma k_{i},+\infty[\right.$ :

$$
\forall i \in[1, N], w_{i}^{\theta}=(1-\theta) w_{i}+\theta p
$$

First, we observe that

$$
\begin{aligned}
p(x)-p(x-\gamma h) & =A+B x+x^{2}-\left(A+B(x-\gamma h)+(x-\gamma h)^{2}\right) \\
& \geq\left[2 \gamma h x+\gamma h B-\gamma^{2} h^{2}\right] \\
& \geq \gamma^{2} h^{2}
\end{aligned}
$$

Moreover, we have

$$
p_{i}^{\prime}(x)-1=B+2 x-1 \geq 1
$$

It remains to prove that

$$
-\mathcal{L}_{i} p(x)>0
$$

By definition,

$$
\begin{aligned}
-\mathcal{L}_{i} p(x) & =r p(x)-\left(\beta\left(k_{i}\right) \mu-\alpha\left(\left(k_{i}-x\right)^{+}\right)\right) p^{\prime}(x)-\frac{\beta\left(k_{i}\right)^{2} \sigma^{2}}{2} p^{\prime \prime}(x) \\
& =r\left(A+B x+x^{2}\right)-\left(\beta\left(k_{i}\right) \mu-\alpha\left(\left(k_{i}-x\right)^{+}\right)\right)(B+2 x)-\beta\left(k_{i}\right)^{2} \sigma^{2} \\
& =\left(r A-\beta\left(k_{i}\right)^{2} \sigma^{2}-\left(\beta\left(k_{i}\right) \mu-\alpha\left(\left(k_{i}-x\right)^{+}\right)\right) B\right)+\left(r B-2\left(\beta\left(k_{i}\right) \mu-\alpha\left(\left(k_{i}-x\right)^{+}\right)\right)\right) x+r x^{2}
\end{aligned}
$$

so using the values of $A$ and $B$ :

$$
-\mathcal{L}_{i} p(x) \geq 1
$$

We then have

$$
\begin{equation*}
\min \left\{-\mathcal{L}_{i} p(x), p^{\prime}(x)-1, p(x)-p(x-\gamma h)\right\} \geq \min \left\{1, \gamma^{2} h^{2}\right\} \tag{25}
\end{equation*}
$$

Finally, take $\bar{x}>\gamma k_{i}$ and $\varphi_{i} \in C^{2}$ such that $\bar{x}$ is a minimum of $w_{i}^{\theta}-\varphi_{i}$. Then with $\varphi_{2}=\frac{\varphi_{i}-\theta p}{1-\theta}, \bar{x}$ is also a minimum of $w_{i}-\varphi_{2}$. So using that $w_{i}$ is a viscosity supersolution of (7) and the result (25) we have that $w_{i}^{\theta}$ is a supersolution of the system

$$
\min \left\{-\mathcal{L}_{i} \varphi(x), \varphi^{\prime}(x)-1, w_{i}^{\theta}(x)-w_{j}^{\theta}(x-\gamma h)\right\} \geq \theta \min \left\{1, \gamma^{2} h^{2}\right\}=\delta
$$

Step 2
Assume by a way of contradiction that there exists $\theta \in] 0, \tilde{\theta}[$ and $i \in[1, N]$ such that

$$
\lambda=\sup _{\substack{i \in[1, N] \\ x \geq \gamma k_{i}}}\left(u_{i}-w_{i}^{\theta}\right)(x)>0
$$

Because $u_{i}$ and $w_{i}$ have linear growth, we have $\lim _{x \rightarrow+\infty}\left(u_{i}(x)-w_{i}^{\theta}(x)\right)=-\infty$ and $\lim _{x \rightarrow \gamma k_{i}}\left(u_{i}(x)-\right.$ $\left.w_{i}^{\theta}(x)\right)<0$. So by continuity of the functions $u_{i}$ et $w_{i}^{\theta}$, there exists $\left.x_{0} \in\right] \gamma k_{i},+\infty[$ such that

$$
\lambda=u_{i}\left(x_{0}\right)-w_{i}^{\theta}\left(x_{0}\right)
$$

For $\epsilon>0$, let us consider the functions

$$
\begin{aligned}
& \Phi_{\epsilon}(x, y)=u_{i}(x)-w_{i}^{\theta}(y)-\phi_{\epsilon}(x, y) \\
& \phi_{\epsilon}(x, y)=\frac{1}{4}\left|x-x_{0}\right|^{4}+\frac{1}{2 \epsilon}|x-y|^{2}
\end{aligned}
$$

By standard arguments in comparison principle of the viscosity solution theory, we know that the function $\Phi_{\epsilon}$ attains a maximum in a point $\left(x_{\epsilon}, y_{\epsilon}\right)$, which converges to $\left(x_{0}, y_{0}\right)$ when $\epsilon$ goes to 0 . Moreover,

$$
\lim _{\epsilon \rightarrow 0} \frac{\left|x_{\epsilon}-y_{\epsilon}\right|^{2}}{\epsilon}=0
$$

Applying theorem 3.2 in Crandall Ishii Lions ([5]), we get the existence of $M_{\epsilon}, N_{\epsilon} \in \mathbb{R}$ such that

$$
\begin{aligned}
\left(p_{\epsilon}, M_{\epsilon}\right) & \in J^{2,+} u_{i}\left(x_{\epsilon}\right) \\
\left(q_{\epsilon}, N_{\epsilon}\right) & \in J^{2,-} w_{i}^{\lambda}\left(y_{\epsilon}\right)
\end{aligned}
$$

and,

$$
\left(\begin{array}{rr}
M_{\epsilon} & 0  \tag{26}\\
0 & -N_{\epsilon}
\end{array}\right) \leq D^{2} \phi_{\epsilon}\left(x_{\epsilon}, y_{\epsilon}\right)+\epsilon\left(D^{2} \phi\left(x_{\epsilon}, y_{\epsilon}\right)\right)^{2}
$$

with

$$
\begin{aligned}
& p_{\epsilon}=D_{x} \phi_{\epsilon}\left(x_{\epsilon}, y_{\epsilon}\right)=\frac{1}{\epsilon}\left(x_{\epsilon}-y_{\epsilon}\right)+\left(x_{\epsilon}-x_{0}\right)^{3} \\
& q_{\epsilon}=-D_{y} \phi_{\epsilon}\left(x_{\epsilon}, y_{\epsilon}\right)=\frac{1}{\epsilon}\left(x_{\epsilon}-y_{\epsilon}\right)
\end{aligned}
$$

and

$$
D^{2} \phi_{\epsilon}\left(x_{\epsilon}, y_{\epsilon}\right)=\left(\begin{array}{rrr}
3\left(x_{\epsilon}-x_{0}\right)^{2}+\frac{1}{\epsilon} & -\frac{1}{\epsilon} \\
& -\frac{1}{\epsilon} & \frac{1}{\epsilon}
\end{array}\right)
$$

so

$$
D^{2} \phi_{\epsilon}\left(x_{\epsilon}, y_{\epsilon}\right)+\epsilon\left(D^{2} \phi_{\epsilon}\left(x_{\epsilon}, y_{\epsilon}\right)\right)^{2}=\left(\begin{array}{rr}
\frac{3}{\epsilon}+9 \epsilon\left(x_{\epsilon}-x_{0}\right)^{4}+9\left(x_{\epsilon}-x_{0}\right)^{2} & -\frac{3}{\epsilon}-3\left(x_{\epsilon}-x_{0}\right)^{2} \\
-\frac{3}{\epsilon}-3\left(x_{\epsilon}-x_{0}\right)^{2} & \frac{3}{\epsilon}
\end{array}\right)
$$

Therefore multiplying by the vector $(1,1)$ and its transpose, (26) implies that

$$
\begin{equation*}
M_{\epsilon}-N_{\epsilon} \leq 3\left(x_{\epsilon}-x_{0}\right)^{2}\left(1+3 \epsilon\left(x_{\epsilon}-x_{0}\right)^{2}\right) \tag{27}
\end{equation*}
$$

Because $u_{i}$ et $w_{i}^{\theta}$ are respectively subsolution and strict supersolution, we have

$$
\begin{array}{r}
\min \left\{-\left(\frac{1}{\epsilon}\left(x_{\epsilon}-y_{\epsilon}\right)+\left(x_{\epsilon}-x_{0}\right)^{3}\right)\left(\mu \beta\left(k_{i}\right)-\alpha\left(\left(k_{i}-x\right)^{+}\right)\right)-\frac{\sigma^{2} \beta^{2}\left(k_{i}\right)}{2} M_{\epsilon}+r u_{i}\left(x_{\epsilon}\right),\right. \\
\left(\frac{1}{\epsilon}\left(x_{\epsilon}-y_{\epsilon}\right)+\left(x_{\epsilon}-x_{0}\right)^{3}\right)-1, \\
\left.u_{i}\left(x_{\epsilon}\right)-u_{j}\left(x_{\epsilon}-\gamma h\right)\right\} \leq 0 \\
\min \left\{-\left(\frac{1}{\epsilon}\left(x_{\epsilon}-y_{\epsilon}\right)\right)\left(\mu \beta\left(k_{i}\right)-\alpha\left(\left(k_{i}-x\right)^{+}\right)\right)-\frac{\sigma^{2} \beta^{2}\left(k_{i}\right)}{2} N_{\epsilon}+r w_{i}^{\theta}\left(y_{\epsilon}\right),\right. \\
\frac{1}{\epsilon}\left(x_{\epsilon}-y_{\epsilon}\right)-1,  \tag{29}\\
\left.w_{i}^{\theta}\left(y_{\epsilon}\right)-w_{j}^{\theta}\left(y_{\epsilon}-\gamma h\right)\right\} \geq \delta
\end{array}
$$

We then distinguish the following cases :

- Case 1: If $\frac{1}{\epsilon}\left(x_{\epsilon}-y_{\epsilon}\right)+\left(x_{\epsilon}-x_{0}\right)^{3}-1 \leq 0$ then using (29), we have $\delta+\left(x_{\epsilon}-x_{0}\right)^{3} \leq 0$ which is a contradiction when $\epsilon$ goes to 0 .
- Case 2 : If $u_{i}\left(x_{\epsilon}\right)-u_{j}\left(x_{\epsilon}-\gamma h\right) \leq 0$ then when $\epsilon$ goes to 0 , we obtain

$$
u_{i}\left(x_{0}\right) \leq u_{j}\left(x_{0}-\gamma h\right)
$$

And using (29), we have

$$
w_{i}^{\theta}\left(y_{\epsilon}\right)-w_{j}^{\theta}\left(y_{\epsilon}-\gamma h\right) \geq \delta
$$

So when $\epsilon$ goes to 0 and using the continuity of $w_{i}^{\theta}$ we obtain

$$
w_{i}^{\theta}\left(x_{0}\right) \geq w_{j}^{\theta}\left(x_{0}-\gamma h\right)+\delta .
$$

Therefore

$$
\begin{aligned}
\lambda=u_{i}\left(x_{0}\right)-w_{i}^{\theta}\left(x_{0}\right) & \leq u_{j}\left(x_{0}-\gamma h\right)-w_{j}^{\theta}\left(x_{0}-\gamma h\right)-\delta \\
& \leq \lambda-\delta
\end{aligned}
$$

which is a contradiction.

- Case 3: If $-\left(\frac{1}{\epsilon}\left(x_{\epsilon}-y_{\epsilon}\right)+\left(x_{\epsilon}-x_{0}\right)^{3}\right)\left(\mu \beta\left(k_{i}\right)-\alpha\left(\left(k_{i}-x\right)^{+}\right)\right)-\frac{\sigma^{2} \beta^{2}\left(k_{i}\right)}{2} M_{\epsilon}+r u_{i}\left(x_{\epsilon}\right) \leq 0$. Then using (29), we have

$$
-\left(\frac{1}{\epsilon}\left(x_{\epsilon}-y_{\epsilon}\right)\right)\left(\mu \beta\left(k_{i}\right)-\alpha\left(\left(k_{i}-x\right)^{+}\right)\right)-\frac{\sigma^{2} \beta^{2}\left(k_{i}\right)}{2} N_{\epsilon}+r w_{i}^{\theta}\left(y_{\epsilon}\right) \geq \delta
$$

So,

$$
-\left(x_{\epsilon}-x_{0}\right)^{3}\left(\mu \beta\left(k_{i}\right)-\alpha\left(\left(k_{i}-x\right)^{+}\right)\right)-\frac{\sigma^{2} \beta^{2}\left(k_{i}\right)}{2}\left(M_{\epsilon}-N_{\epsilon}\right)+r\left(u_{i}\left(x_{\epsilon}\right)-w_{i}^{\theta}\left(y_{\epsilon}\right)\right) \leq-\delta
$$

But according to (27), we have

$$
\frac{\sigma^{2} \beta^{2}\left(k_{i}\right)}{2}\left(M_{\epsilon}-N_{\epsilon}\right) \leq \frac{3 \sigma^{2} \beta^{2}\left(k_{i}\right)}{2}\left(x_{\epsilon}-x_{0}\right)^{2}\left(1+3 \epsilon\left(x_{\epsilon}-x_{0}\right)^{2}\right)
$$

Therefore
$r\left(u_{i}\left(x_{\epsilon}\right)-w_{i}^{\theta}\left(y_{\epsilon}\right)\right) \leq\left(x_{\epsilon}-x_{0}\right)^{3}\left(\mu \beta\left(k_{i}\right)-\alpha\left(\left(k_{i}-x\right)^{+}\right)\right)-\delta+\frac{3 \sigma^{2} \beta^{2}\left(k_{i}\right)}{2}\left(x_{\epsilon}-x_{0}\right)^{2}\left(1+3 \epsilon\left(x_{\epsilon}-x_{0}\right)^{2}\right)$
so when $\epsilon$ goes to 0 and using the continuity of the functions, we have the contradiction

$$
r \lambda \leq-\delta<0
$$

Thus we have proved that for all

$$
\forall \theta \in] 0, \tilde{\theta}\left[, \forall i \in[1, N], \sup _{x \in\left[\gamma k_{i},+\infty[ \right.}\left(u_{i}-w_{i}^{\theta}\right) \leq 0\right.
$$

and the final result is proved by sending $\theta$ to 0 .

### 6.2 Proof of Theorem 1

Using the approximations $q$ and $q+1$, the system (17) can be written as :

$$
\begin{aligned}
A^{q+1}\left(U^{q+2}-U^{q+1}\right)+A^{q+1} U^{q+1}-A^{q} U^{q+1} & =-B^{q+1}+B^{q} \\
A^{q+1}\left(U^{q+2}-U^{q+1}\right) & =A^{q} U^{q+1}+B^{q}-\left(A^{q+1} U^{q+1}+B^{q+1}\right)
\end{aligned}
$$

We know that $\left(\rho^{q+1}, \psi^{q+1}, \theta^{q+1}\right)$ minimize $A(\rho, \psi, \theta) U^{q+1}+B(\rho, \psi, \theta)$ so

$$
A^{q+1}\left(U^{q+2}-U^{q+1}\right) \geq 0
$$

Then using that $A^{q+1}$ is a M-matrix we have

$$
U^{q+2}-U^{q+1} \geq 0
$$

Therefore the scheme is non-decreasing. Morevover $\left(A^{q}\right)^{-1}$ and $B^{q}$ are bounded regardless of $q$ so using that

$$
U^{q+1}=-\left(A^{q}\right)^{-1} B^{q}
$$

we know that $U^{q}$ is also bounded so the scheme is convergent. We note $U^{*}$ the limit of $\left(U^{q}\right)_{q \in \mathbb{N}}$. We still have to prove that the limit is unique and independent of $U^{0}$. Suppose there exists $U^{*}$ and $\bar{U}^{*}$ two limits. $U^{*}$ and $\bar{U}^{*}$ are both solutions of (13) so

$$
\begin{aligned}
& A^{*} U^{*}+B^{*}=0 \\
& \bar{A}^{*} \bar{U}^{*}+\bar{B}^{*}=0
\end{aligned}
$$

then subtracting the two equations we have,

$$
\bar{A}^{*}\left(\bar{U}^{*}-U^{*}\right)=B^{*}+A^{*} U^{*}-\left(\bar{B}^{*}+\bar{A}^{*} U^{*}\right)
$$

$\operatorname{But}\left(\bar{\rho}^{*}, \bar{\psi}^{*}, \bar{\theta}^{*}\right)$ minimize $\bar{A} \bar{U}^{*}+B$ so

$$
\bar{A}^{*}\left(\bar{U}^{*}-U^{*}\right) \leq 0
$$

Then using that $\bar{A}^{*}$ is a M-matrix we have

$$
\bar{U}^{*}-U^{*} \leq 0
$$

We prove in the same way that

$$
\bar{U}^{*}-U^{*} \geq 0
$$

which achieves the demonstration.
